### WHAT IS COVERED?

The product warranty covers all defects in materials during the warranty period (specified above, except otherwise limited herein). Factory workmanship is warranted for a period of one year. In the event field service is required, the labor and field service will be covered free of charge for a period of one year from date of install. If the product is sent to the factory after the warranty period, it must be sent pre-paid. King Awning Inc. will fix the equipment or parts, or replace them, at its option. If we choose to replace the equipment or parts, we may replace it with reconditioned or equivalent items similar in type and quality. Powder coating paint finishes are warranted for 1 year against excessive peeling only.

### WHAT IS NOT COVERED BY THIS WARRANTY?

- (1) Damage caused by accident, negligence, water pooling, misuse, abuse, alteration and failure to follow instructions, improper operation, civil disorder, windstorm, rainstorm, fire, flood, earthquakes, and other acts of God or Failure to provide a reasonable degree of maintenance, or any other condition in which King Awning Inc. has no control.
- (2) Damage resulting from repair or attempted repair by a non-authorized King Awning Inc. service technician.
- (3) The cost of loss of time, loss of use, or any consequential or incidental damages or outside labor.
- (4) Damage/ Deterioration, to any fabric or valance free hanging loose in the wind.
- (5) After three years the travel time and site labor to repair equipment in the field (i.e. the service call labor).
- (6) Freight costs to return the product to the factory for repair.

### WHAT IS LIMITED UNDER THIS WARRANTY?

- (1) Valances and binding: Since valances and binding are subject to fraying as a result of their greater potential for interaction with their environment, the warranty is limited for 1 year.
- (2) The installation if done by King Awning Inc is covered for 10 years
- (3) All Powder Coating is limited to 1 year warranty against excessive peeling only.
